- The Board approved the motion to hold a General Membership meeting on February 10, 2018 at 1:30 PM to vote on the recommendation ot approve the concept design and floor plan prepared by Herold Engineering Ltd. And

to authorize construction of the expansion of Forbes Hall as designed.

Information needs to be established so that the Hall Manager can deal with booking requests and scheduling.
