Hall Expansion: Ron said that the Expansion Committee will be using data given to them by our Treasurer and will be making telephone calls to solicit donations.

The Forbes Hall Expansion Committee asked that TICA engage the services of qualified grant writer Jennifer Baines van Elk to prepare and file the Capital Project Grant and the Community Gaming Grant applications, both through BC Gaming at the Ministry of Community, Sport and Cultural Development. A motion to do so was made and approved by the Board.

Hall Cleaning: Connie Schermerhorn will be doing the cleaning for the month of March while Janice Young is still recovering from a health issue.
